strongly recommends that you reevaluate your plan to ensure it is current and complete.


The following are some points to consider:

- Ensure all listed personnel and contact information is current.
- Ensure all evacuation plans include changes in facilities and facility sites.
- Are there any changes in the surrounding areas and neighborhoods in which your facilities are located?
- Are there any new manufacturing processes or products that have a hazard potential?
- Decrease the amounts of hazardous, explosive, or combustibles stored on your facility site or inside your actual facilities.
- Review all emergency contact information on your employees, and focus on employees whose job tasks include travel.
- Ensure the contact information on your emergency responders (fire / police / medical) is

current, and any new potentials are communicated to them, if necessary.

- Review your corporate policy regarding responses to any threats, if applicable (What do you do and who makes the decisions?).
- Ensure all your facilities (domestic/USA and international) fully understand corporate expectations as to the Emergency Response Plan.
